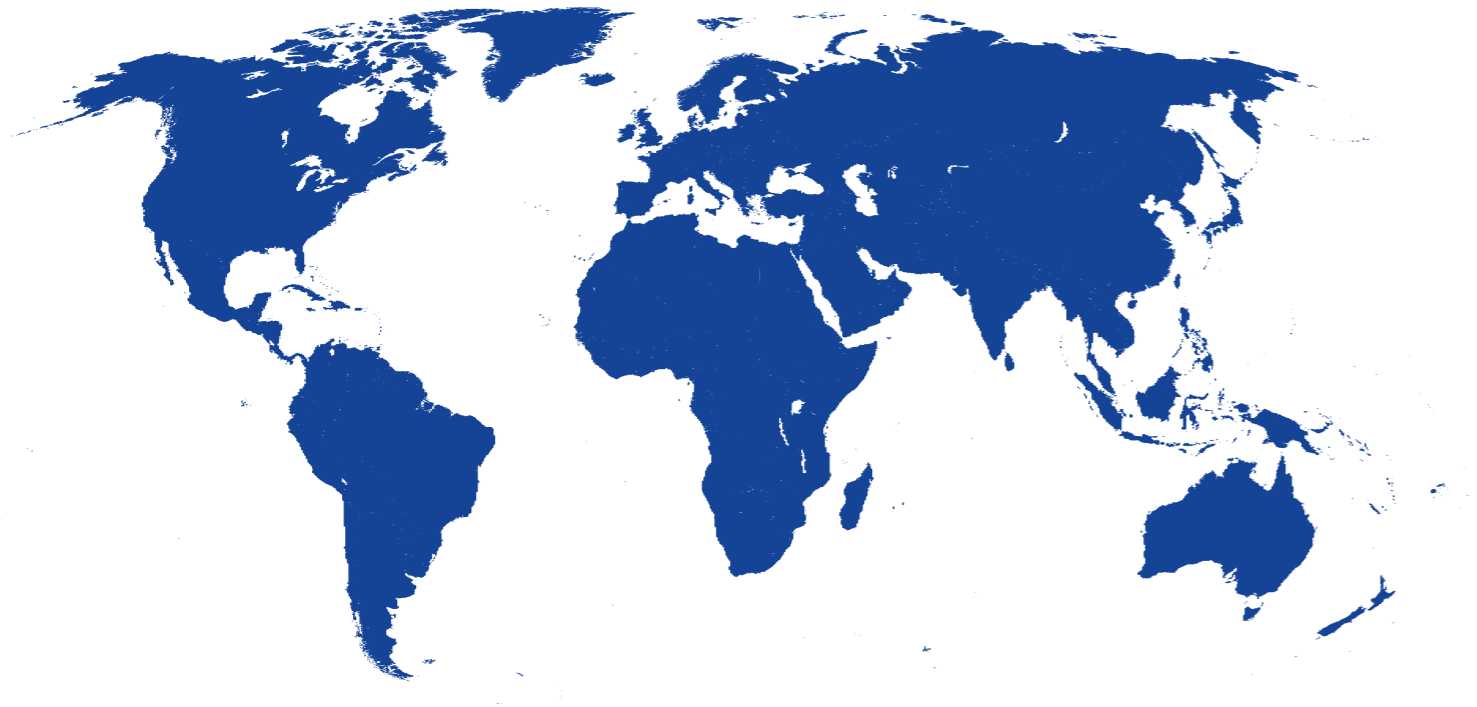


## Unlimited investements.

Both offer portfolios with clearly structured products and provide specific advice regarding the financial markets, always aiming to identify the best investment products worldwide.



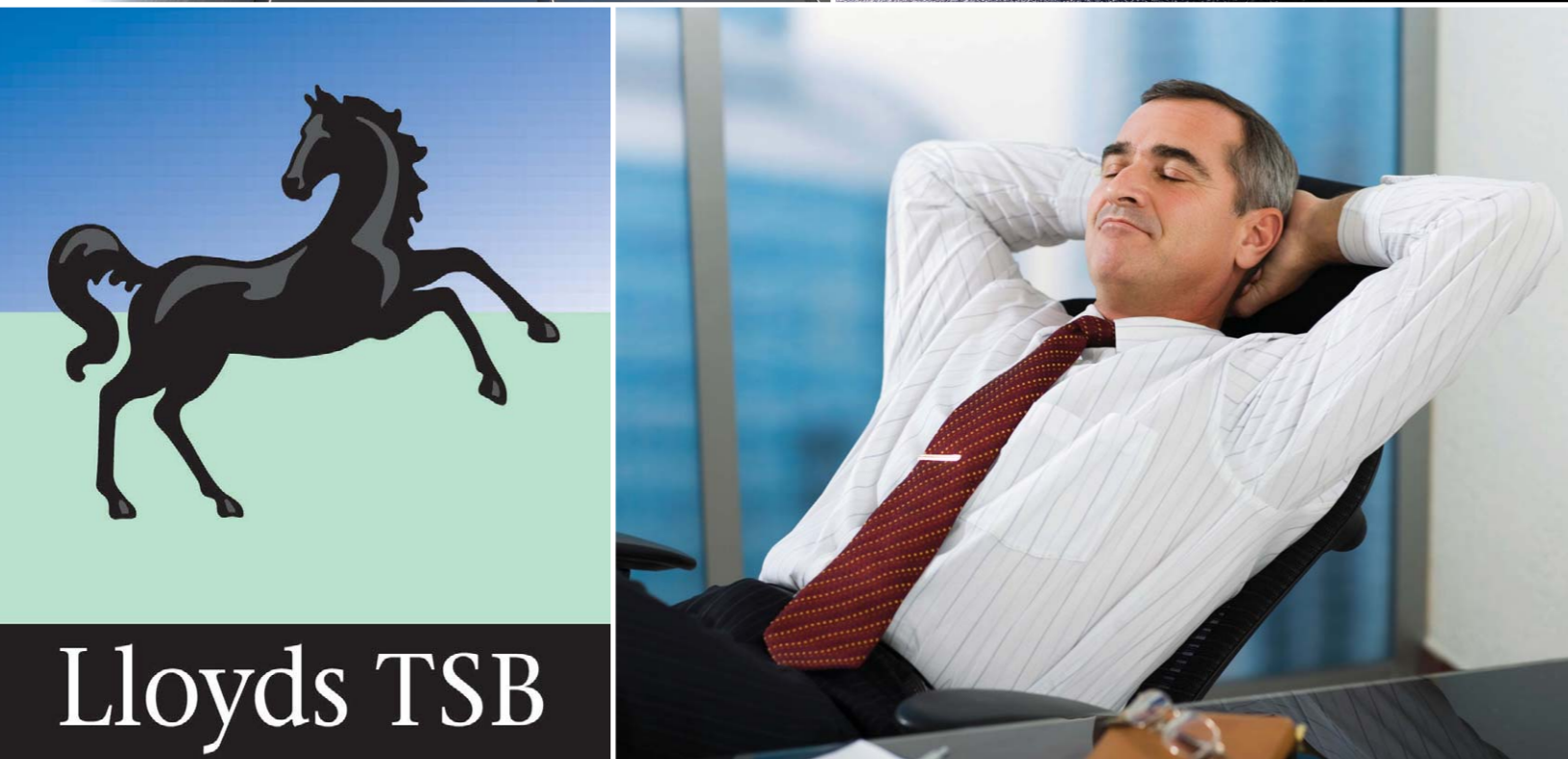
## Collateral.

All this makes us a competitive, dynamic and successful company in the financial market and in the public.

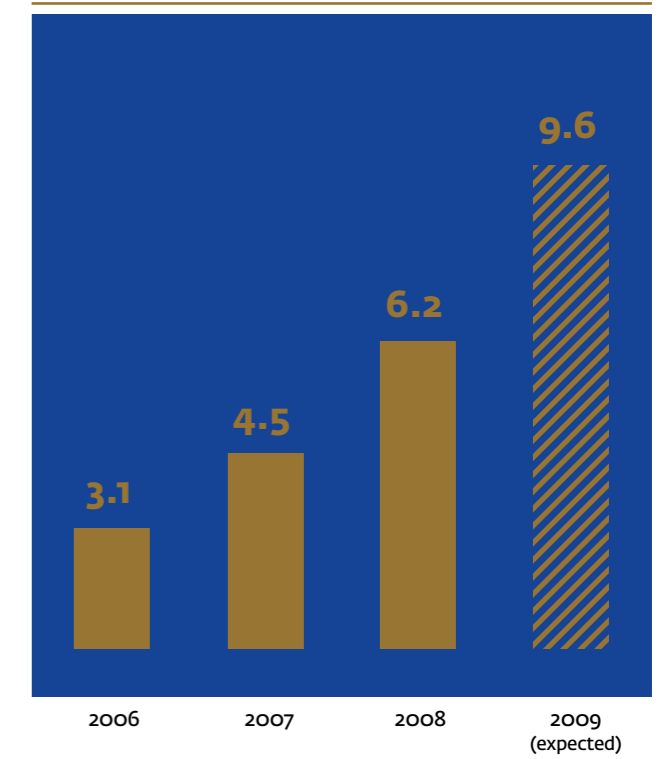
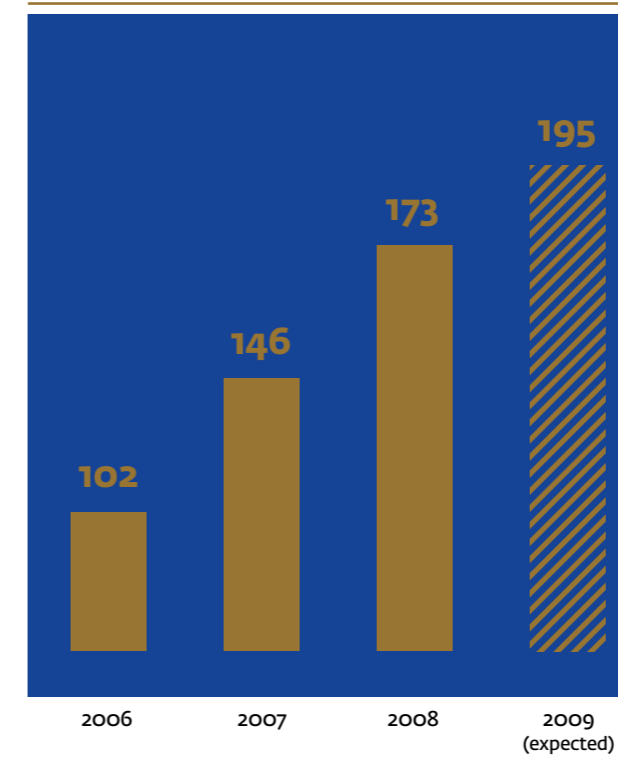

## Capital Investors in numbers.

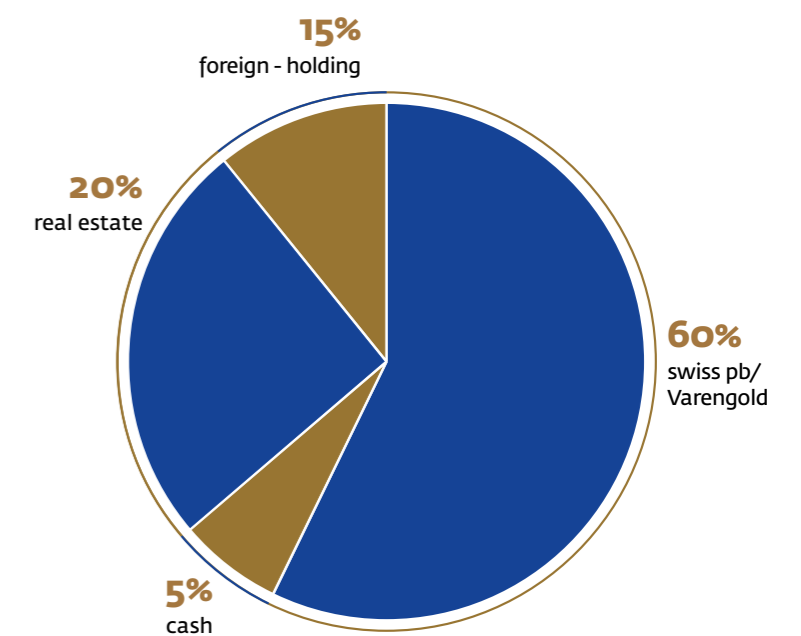
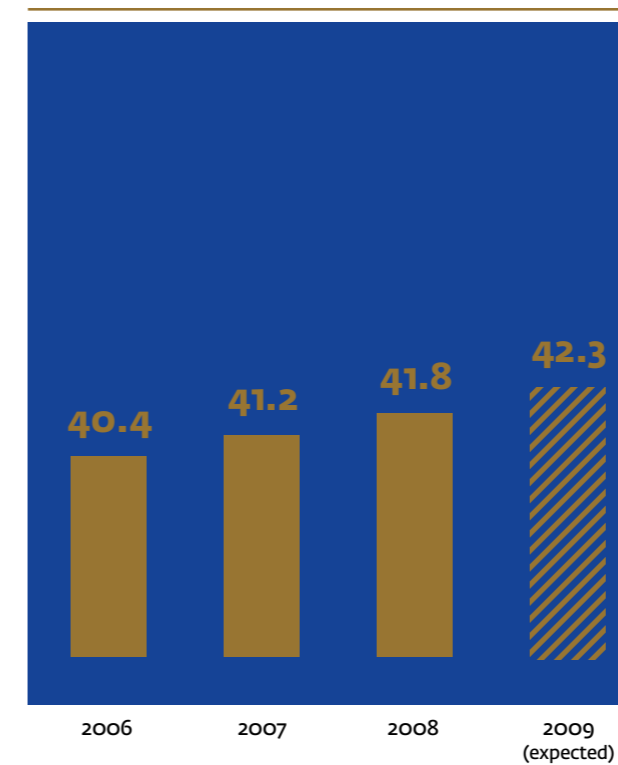
## Shareholders number.
